My name is Cody Faulk and I represent the City of Kyle. I am in receipt of your correspondence regarding the 2007 Interlocal Agreement. To answer your question simply, the City Council did provide authority to the City Manager to enter into this agreement in 2006. You can see the attached minutes and resolution, as well as the signed 2006 Interlocal Agreement. What seems to have drawn out this issue is the fact that the 2006 Interlocal Agreement contained the incorrect property description which was later remedied by the 2007 agreement which both cities signed. The 2007 Agreement is valid despite the City Council not resolving that Mr. Mattis could sign it since they had already given authority in 2006, and the 2007 agreement was not a material change from the original agreement.
