

# CITY OF KYLE, TEXAS AMENDMENT TO REQUESTS FOR PROPOSAL (RFQ) FOR INSPECTION AND PLAN REVIEW SERVICES January 10, 2024.

### **NOTICE TO RESPONDERS:**

The City of Kyle is accepting proposals for inspection and plan review services for the City of Kyle's Building Department as stated in the RFP released November 17<sup>th</sup>, 2023, and posted on our website: www.cityofkyle.com. Based on questions received via email and at the Pre-Proposal Meeting held at City Hall on Tuesday, January 5, 2024, the information below is being provided as an Amendment to the posted RFQ.

## Q: Can we include staff that may currently work for other contractors that are working for the city in the proposal?

A: Yes, just please communicate any staff turnover as quickly as possible.

#### **Q: ICC certifications for proposal?**

A: Submit info and we will verify.

#### Q: Original/ wet signature needed on proposal?

A: No.

#### Q: What system do you use?

A: Energov/ IG inspect

#### Q: Can we add people to the RFP email group?

A: Yes, please forward them to <u>kstilwell@cityofkyle.com</u>.

#### Q: Do you want background checks on the proposal?

A: Just verify you have done background checks.

#### Q: MCP certs?

A: Acceptable for plan review or inspections with Texas State Board of Plumbing Examiners Inspector License for inspections.

#### Q: CBO certs?

A: Acceptable for plan review and inspections with Texas State Board of Plumbing Examiners Inspector License for inspections.

#### Q: Ave daily inspection?

- A: Gave monthly breakdown.
- A: Based on last 3-year average 140 per day.

#### **Q: Track inspectors?**

A: No. Inspectors are assigned all.

#### **Q:** Do inspectors report to the office?

A: They are your employees. We would like to meet them, but dispatch is up to you.

#### Q: Plan check digital or paper?

A: Digital

#### Q: How does IT set it up.

A: currently your iPad and our software

#### Q: How quickly will RFP be awarded?

A: Quickly. 48 hrs.?

Clarification: While we will make our selection quickly an official announcement will not be made until approval is obtained from the City Council. The first available meeting is February 6<sup>th</sup>, and I hope to make that agenda and make the announcement shortly thereafter.

#### Q: Are proposed team résumés included or excluded from the 30-page limit?

A: Resumes are not necessary for submittal please just provide work history, education, and certifications and licenses listed in RFP.

### Q: Will the City of Kyle accept proposals for only Plan Review Services, or must we provide both building inspection and plan review services?

A: We are currently only looking for contractors capable of providing inspection and plan review services.
