

Response Project: Bebee Road



Limits: Frontage Road to Goforth Road (2.1 miles)

Objective: Realign sharp curves and upgrade roadway

Typical Section: 4-lane minor arterial east of Seton Pkwy extension; 2-3 lane collector west of Seton Pkwy extension

Includes: Roundabouts and possible extension of city utilities

SCOPE OF WORK



Scope of Work

Overview

- Intent is to execute Master Agreements, then to execute the first Work Authorization focused on Phase 1 (Preliminary Engineering)
- A Preliminary Engineering Report (PER) (10% Concept Plan) for each project will be due to the City in late July 2022
- Further phases of work are dependent on the decisions of the bond committee and voters



Scope of Work

Preliminary Engineering Report (10% Concept Plan)

- Refined project description
- Preliminary analysis of project challenges and opportunities
- Preliminary schedule for project development
- Identification of utility relocations and which of them are in conflict with the project
- Refined cost estimate (including estimate for city driven utility relocations)
- Preliminary roll plot depicting horizontal and vertical alignment
