### **Burleson Street**

• Project closeout in progress



- Consent Agenda Item Nos. 12 & 13
- Based on pay estimates overall project is 12% completion
- Installing retaining wall footings and bridge drilled piers





- Based on pay estimates overall project is 7% completion
- Temporary access from Doherty has been completed





## Mary Kyle Hartson Park Project

- Work 22% complete
- North portion of underground conduits complete
- Northern sidewalk & bike rack concrete has been placed
- Flagpoles installed
- Currently forming and placing concrete curbs on northwest portion of park



• Excavation of playground area & irrigation main line trenching in progress



# Windy Hill Street & Drainage Project

- Based on pay estimates, overall project is 80% complete
- Traffic driving on north half of Windy Hill
- Change Order 4 almost complete
- Currently working on sidewalk, drainage & topsoil
- Eastbound lane closure scheduled one day on Sept 14<sup>th</sup>
- Final asphalt surfacing scheduled on Sept 14<sup>th</sup> & 15<sup>th</sup>
- Windy Hill tentative opening in Oct 2021




### Windy Hill Street & Drainage Project





- Based on pay estimates, overall project is 88% complete
- Working in front of Alexander tracts & along CR 158





## WWTP Expansion Project

- Based on pay estimates, overall project is 71% complete
- Forecast and previous rain events will impact construction progress and require continued Saturday workdays
- All major treatment unit concrete placements have been completed. Minor concrete placements will continue
- No deviations between construction progress and construction schedule
- Expansion completion and on-line in March 2022
- Dewatering Facility completion in August 2022

• Tank is completed






- Resolving Right-of-Way issue
