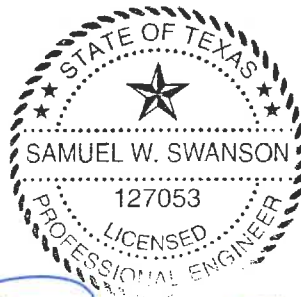

**INVITATION FOR BIDS**

**1. OVERVIEW AND PROJECT INFORMATION**

Following is a summary of information for this Project. Bidder is cautioned to refer to other sections of the Project Manual, Drawings and Addenda (Bid Documents) for further details.

The City of Kyle, hereafter called OWNER, is requesting sealed written Bids for furnishing all labor, materials, equipment, supervision, and incidentals, and for performing all Work required for the following:

Scope	New influent piping and junction appurtenances; screening headworks and influent lift station; new operations center building; new aeration basins, diffusers, mixers, and aeration blowers; new secondary clarifiers and return, waste, and scum pumps; new UV disinfection channels; new post-aeration basins and blowers; new aerobic digesters and blowers; new vector truck receiving station; modifications to existing treatment facilities; electrical and control system, piping, and appurtenance upgrades to be installed within and around new and existing facilities (including new access road to site).

**3. SUBMISSION OF BIDS**

Sealed Bids will be received addressed to the City of Kyle will be received for the Project until 2:00 p.m. on Thursday, November 14, 2019 at City of Kyle Public Works Department, 520 E. RR 150, Kyle, Texas. The bids will be publicly opened and read aloud starting at 2:01 pm on Thursday, November 14, 2019 at City of Kyle Public Works Department Training Room.

**4. BID GUARANTY**

All Bids shall be accompanied by an acceptable Bid guaranty in an amount of not less than five percent (5%) of the total Bid, as specified in Section 00 10 00, Instructions to Bidders. The security shall be in the form of a certified check or cashier’s check, or bid bond furnished by a reliable surety company having authority under the laws of Texas to write surety bond in the amount required, with such security made

payable without recourse to the City of Kyle. The envelope containing the bid shall be submitted in a sealed envelope clearly marked: **Wastewater Treatment Plant Expansion.**

**5. BONDS AND INSURANCE**

Performance and payment bonds when required shall be executed on forms furnished by OWNER. Each bond shall be issued in an amount of one hundred percent (100%) of the Contract Amount by a solvent corporate surety company authorized to do business in the State of Texas, and shall meet any other requirements established by law or by OWNER pursuant to applicable law.

Minimum insurance requirements are specified in Section 00 75 00, Supplemental General Conditions.

**6. WAGE COMPLIANCE**

The prevailing wage rate for labor shall be paid to all workers in compliance with Government Code Chapter 2258.

**7. CONTRACT TIME**

Contract Time is of the essence and all Work shall be substantially completed within 650 days after date specified in the Notice to Proceed, in accordance with the Bid Form, Section 00 30 00.

Completion shall be achieved within 30 days after substantial completion.

Liquidated damages are \$750 per day for failure to substantially complete the work and an additional \$250 per day (\$1,000 total) for failure to achieve final completion within 30 days after substantial completion, in accordance with the Bid Form, Section 00300.

**8. OWNER'S RIGHTS**

OWNER reserves the right to reject any or all Bids and to waive any minor informality in any Bid or solicitation procedure (a minor informality is one that does not affect the competitiveness of the Bid).

**9. PRE-BID CONFERENCE**

A mandatory Pre-Bid Conference will be held on October 29, 2019 at the Public Works Building, 520 E. RR 150, Kyle, Texas 78640, and will proceed to the wastewater treatment plant site. The conference will start promptly at 2:00 PM and conclude at approximately 4:30 PM.

**10. AUTHORIZED CONTACT PERSON**

The City Engineer, Leon Barba, P.E., may be contacted for information regarding the Invitation for Bid.

**11. SUPPLEMENTAL ENVIRONMENTAL PROJECT NOTICE**

The replacement of the bar screens with screening headworks at the wastewater treatment plant, as outlined in the scope of work of in Paragraph 1, above, is being performed as part of the City's Supplemental Environmental Project, as detailed in the Agreed Order between the City and Texas Commission on Environmental Quality (TCEQ) in TCEQ Docket No. 2017-1734-MWD-E, which settled an enforcement action brought by the TCEQ.
