GOVERNMENT CODE AND SECTION 551.074, PERSONNEL MATTERS, TO RECEIVE ADVICE FROM LEGAL COUNSEL REGARDING THE NEED TO APPOINT A THREE-MEMBER BOARD OF DOCTORS TO CONDUCT AN EVALUATION ON A POLICE OFFICER TO DETERMINE SUFFICIENCY TO RETURN TO DUTY IN ACCORDANCE WITH SECTION 143.081 OF THE LOCAL GOVERNMENT CODE.




