Council Member Rizo seconded the motion.

He asked if adjustments could be added a later time. Mr. Barba stated that the contractor intends to keep the cost as close to the original approved amount as possible, but if something happens the contingency allows them to keep the project moving forward.

Mayor Mitchell brought forward Item No. 19 for discussion. Mr. Sellers stated that he and the applicant will be working on an agreement and would like to postpone until the next meeting.

Mayor Mitchell moved to postpone Item No. 19 until the next regularly scheduled council meeting. Council Member Ellison seconded the motion. All votes aye; motion carried 7-0.

17. Request to Consent for the Addition of Land to North Hays County Municipal Utility District No. 1. ~ J. Scott Sellers, City Manager

Mayor Mitchell brought back Item No. 17 for discussion. Mr. Sellers presented the item.

Ms. Deborah and Dennis Lake spoke. She spoke about being a retired schoolteacher of Hays CISD. She spoke about their 25.3 acres, which they planned to sell to supplement their retirement. They have their property for sale but have found it is impossible to sell unless they are annexed into the MUD. Mr. Lake stated that they have lived on this property for almost 50 years. He spoke about Windy Hill widening, that they did not fight, they allowed it, and they also allowed the easement for access by giving away a portion of their property to get to the MUD's Wastewater Treatment Plan through their property. He stated that the treated wastewater then comes back through their property into a creek for about 800 feet, cutting off two acres of their property. He stated that it runs 24 hours a day and that has gone on for years. He stated that the subdivision across the street was annexed and granted access into the MUD and they respectfully request to be treated equally to preserve the value of their property. Harrison Hudson, with Kimley-Horn, spoke about City of Kyle not having wastewater services anywhere near the property.

Council discussion resumed. With no one making a motion, and no objections to moving on, Mayor Mitchell moved on with no action taken on Item No. 17.
