#### Other Information:

City of Kyle Staff met with the Hays County consultant team for the IH-35 at Yarrington Road Improvements Project (TxDOT CSJ 0016-02-135) [Project] on November 28, 2012. The Project will affect the City's utilities along the proposed improved sections of Yarrington Rd. east of IH-35 and along the east side of IH-35; a total of approximately 2,000 feet. This affects the City's existing 12-inch waterline along this entire route. Under TxDOT's Utility Accommodation Policy the City is responsible for the relocation of its utilities affected by the Project, and then all costs associated with the in-kind relocation (e.g. – design, easement acquisition, construction, etc.) are subject to reimbursement by the State.

The City solicited Requests for Qualifications for professional services for the above referenced project from a total of three (3) firms. The expedited nature of this project (e.g. - 100-percent complete design plans by the end of January 2013, and; letting by TxDOT in June 2013) warrants the format of this limited solicitation. As the preceding indicates, the intent of the project is to yield some economies by including the construction related items in the Project bid package.

Staff evaluated the SOQ's, ranking them in order and the final rankings are attached.

With City Council's authorization, City Staff will negotiate for the engagement of the above firm to perform professional services for the development of Construction Plans, Acquisition Services, Specifications and Estimates, and limited Bid and Construction Services for the construction of the City's utilities affected by the Project. The referenced authorization will include all permitting, identification of utility requirements and conflicts, required utility adjustments and replacement, coordination with utility companies and attending of utility coordination meetings, acquisition of easements, and any other items necessary to successfully develop and consistem the

project.

These professional services (as well as the constructed utility improvements) will be subject to reimbursement from the State. A separate Advance Funding Agreement (AFA) will be executed between the City and State (TxDOT) for this purpose. The design portion of these professional services will develop an estimate of total project cost (s) to be subject to the provisions of this AFA.

City Staff will negotiate the planned scope of services, project deliverables and the proposed budget for the services to be provided and easement(s) to be acquired; amount not to exceed \$300,000. We recommend use of a 'sample contract' to be provided by the selected consultant to be adapted to the City's needs in concert with the City Attorney and the selected consultant. Any attendant outside legal services are not a part of this authorization.

Note that the requested amount is for engineering services and acquisition of easement(s) only. These funds are not for the construction of the improvements.

#### I. INTRODUCTION

The City of Kyle desires to retain a licensed professional engineering team (licensed in the State of Texas) to provide comprehensive engineering services, to include design, surveying, easement acquisition services and other specialties as may be needed for the design of the Utility Relocations for IH-35 at Yarrington Road Improvements. A copy of the conceptual project limits is attached.

#### II. BACKGROUND

The City desires to develop 'bid ready' fully designed and engineered plans for the Utility Relocations for IH-35 at Yarrington Road Improvements for inclusion in the related TxDOT construction package. This project will have the following characteristics:

- The Utility Relocations for IH-35 at Yarrington Road Improvements will extend a distance of approximately 2,000 feet located along the north side of Yarrington Road, from the City's existing Yarrington Road Pump Station, and the east side of the northbound IH-35 frontage road to the limits of TxDOT's IH-35 at Yarrington Road Improvements project.
- The improvements will consist of the relocation of an existing 12-inch waterline. The replacement line size will be an alternate of one of the following: a) 12-inch; b) 16-inch, or; c) 24-inch.
- Sixty (60) percent plans shall be ready by January 31, 2012 for inclusion in the submittal to TxDOT along with the *IH-35 at Yarrington Road Improvements* project plans.
- One-hundred (100) percent plans shall be ready by March 31, 2012 for inclusion in the submittal to TxDOT along with the *IH-35 at Yarrington Road Improvements* project plans.
- All processes will meet TxDOT *Utility Accommodation* requirements including compliance with *Reimbursement Guidelines and Billing Procedures for Utility Adjustments*.

Sixty (60) percent plans prepared by CP&Y, design consultant for the TxDOT improvements, are available for use upon request.

#### III. SCOPE OF SERVICES REQUESTED

- A. Compliance with federal, state and local regulations related to this type of project.
- B. Preparation of any status reports, submittals and documentation required by the Owner and TxDOT.





SUBJECT: Approve award and authorize the negotiation of a professional services agreement with LOCKWOOD, ANDREWS, & NEWMAN, INC., to perform the engineering services, including acquisition of easement rights, associated with the relocation of the City of Kyle utilities impacted by the IH-35 at Yarrington road improvements project (TxDOT CSJ 00116-02-135) for a not to exceed amount of \$300,000.00.

#### **CURRENT YEAR FISCAL IMPACT:**

The City will incur cash outlay in advance for project specific expenditures including engineering, design, and easement acquisition services estimated not to exceed \$300,000.00. The City will enter into an Advance Funding Agreement (AFA) with the Texas Department of Transportation (TxDOT) to subsequently receive reimbursements.

In addition to the engineering and design costs, the City will also be responsible for advance funding the construction costs for this project in anticipation of receiving reimbursement from TxDOT. The Advance Funding Agreement between the City and TxDOT has not yet been authorized by the City Council, which upon execution, will establish the terms and conditions and the maximum amounts that the City will be reimbursed for this project.

#### FUNDING SOURCE OF THIS ACTION:

The City Council, as part of approving this contract award to LAN, will also be authorizing the City Manager to "advance or loan" cash from the Fund Balance of the City's Utility Fund in the amount of \$300,000.00 to pay for engineering, design, and easement acquisition services in anticipation of the Utility Fund being reimbursed by TxDOT.

It is important to note that should the Advanced Funding Agreement with TxDOT, which is planned for City Council's authorization in the future, fails to provide for the City to be reimbursed 100 percent for all funds advanced for this project or should the City fail to fully comply with the terms and conditions of the Advance Funding Agreement with TxDOT, the City assumes complete risk of paying for all of the expenditures incurred to the extent not reimbursed by TxDOT.

Under such circumstances, all project expenditures that is not reimbursed by TxDOT will cause for an immediate water utility rate increase. As an alternative, the City Council could direct that all non reimbursed amounts be paid from the City's General Fund in which case, an adverse impact on the City's property tax rate will result.
