I. Call Meeting to Order and Roll Call

Mayor Mitchell called the meeting to order at 7:02 p.m. The Pledge of Allegiance was recited. Mayor Mitchell asked the city secretary to call roll.

Present were: Mayor Mitchell, Mayor Pro Tem Rizo, Council Member Heiser, Council Member Zuniga, Council Member Harris, and Council Member Parsley. A quorum was present. Council Member Tobias was absent.

Mayor Mitchell moved to excuse Council Member Tobias's absence from this meeting. Council Member Heiser seconded the motion. Motion passed 6 - 0.

II. Approval of Minutes

Mayor Pro Tem Rizo moved to approve the minutes of the February 20, 2024 Special Council Meeting and the minutes of the February 20, 2024 Council Meeting. Council Member Heiser seconded the motion. Motion passed 6 - 0.

III. Citizen Comment Period with City Council

Mayor Mitchell opened citizen comments at 7:04 p.m.

John Carter was called to speak as registered in opposition of Item No. 21. He expressed his opposition to item #20. He quoted from the Bible. He stated that it was in violation of God's will.

Helen Sue Carter was called to speak as registered in opposition of Item No. 21. She expressed that there were laws regarding the pride theme. She spoke of a headline that states Attorney General says celebration of pride events violates state law. She quoted laws and penalties regarding the pride theme. She asked if City of Kyle was ready to deal with lawsuits. She stated that is about children.

Stephanie McDonald was called to speak as registered in opposition of Item No. 21. She urged the City Council to not direct the City Manager to designate a pride themed market day, stating it is not the government's place to politicize city-sponsored events. She continued that it is a market day intended for shopping. She expressed her concern about the event polarizing and dividing the community. She asked that the discussion item be moved to the top of the agenda.

Michael McDonald was called to speak as registered in opposition of Item No. 21. He expressed that it is called Kyle Market Days, and spoke about all the usual activities of selling and buying wares, buying and creating arts and crafts, for farmers selling fruits and vegetables, and to listen to live music. He stated that this is a gathering of all citizens and supported by the citizens tax dollars. He expressed what it is not: political, meant to elevate one group of people over another, to be used to divide the citizens of Kyle, or where organizations come to recruit new members. He used the example of sports and entertainment, and how the decisions made still divide our country today.

Armando Escalante was called to speak as registered in opposition of Item No. 21. He expressed his concern of this leading to groundwork for municipal suicide. He stated that this isn't about pride, but rather a communist agenda. He read excerpts from a Gay Communist News manifesto published in February 1987 to express where things like this come from. He concluded that if council approves this item, it will lay the groundwork for municipal suicide.

Eileen Escalante was called to speak as registered in opposition of Item No. 21. She stated a quote from John Adams. She stated that we have a good country but expressed her concern of special interest groups oppressing Christians. She stated that sexuality belongs in the home, not the public square. Ms. Escalante continued that the government should not use taxpayer money to promote these types of events, that it's oppressive to the rest of the citizenry and it's wrong.

With no one else wishing to speak, Mayor Mitchell closed citizen comments at 7:18 p.m.

Council Member Heiser voted aye; Mayor Mitchell voted aye; Council Member Parsley voted nay; Council Member Zuniga voted aye; Council Member Rizo voted aye; and Council Member Harris voted aye. Motion passed 5 - 1 with Council Member Parsley dissenting.

Council Member Zuniga moved to reconsider agenda item No. 21. Council Member Parsley seconded the motion. Motion failed 2 - 4.

Jesse Elizondo introduced Gavin Lopez, Marketing Chair for KAYAC and Anthony Jaramillo, Vice President of KAYAC to present the item. They discussed what the capstone project consists of. They invited everyone to go observe the capstone project, date to be provided at a later time, and also informed Council that there will be an opportunity to purchase a stone to put on the trail at the park that will be there forever. The proceeds of the rocks would go to the Forever 15 Foundation. No action was taken.
