I. Call Meeting to Order and Roll Call

Mayor Mitchell called the meeting to order at 7:14 p.m. The Pledge of Allegiance was recited. Mayor Mitchell asked the city secretary to call roll.

Present were: Mayor Mitchell, Mayor Pro Tem Rizo, Council Member Heiser, Council Member Zuniga, Council Member Harris, Council Member Parsley, and Council Member Tobias. A quorum was present.

Mayor Mitchell opened citizen comments at 7:15 p.m.

Edward Bradley of Kyle's Bright Beginnings was called to speak as registered in favor of Item No. 18. He thanked Council for bringing forward the item and mentioned that the deadline for approval is April He spoke about the requirements to qualify for the tax relief. He spoke about the potential ability to use the funds to provide reduced tuition to families and other options like healthcare benefits to staff. He spoke about the economic implications, stating that this decision will be a good one. He stated that childcare provides many social benefits.

Yvonne Flores-Cale was called to speak as registered. She thanked Ms. Chapa for her service to the community and wished her a happy birthday. She asked Council to vote yes to Agenda Item No. 8 and proposition 2 to hopefully provide relief to Kyle families.

Stephanie McDonald was called to speak as registered. She stated that voting on health insurance is unethical at the least. She stated that she believes that people didn't want Council to not have health insurance but shouldn't have the same benefits as the full-time employees. She thanked the council members who voted against the item. She spoke about market days, stating that this should be a day of shopping and carefree fun. She stated that the City is almost out of water. She stated that the water deficit will last through 2038. She stated that people may not realize that people can only water one day per two weeks between 7:00 pm and 10:00 pm. She stated that while this is going on, the City continues to build like crazy. She urged more citizens to get involved.

Michael McDonald was called to speak as registered. He stated that on March 18, 2024, he wrote a letter to the City Manager and Council regarding market days. He stated that as of today, he's received only two responses from Council. He received a call from Council Member Tobias and received an email from Council Member Parsley. He described privilege and accountability to the council. He asked whether Council read his email.
