Chairman Rubsam requested a roll call vote. Commissioner Bowman voted aye; Commissioner Cohen voted aye; Commissioner Fahy voted aye; Commissioner Growt voted aye; Chairman Rubsam voted aye; and Commissioner Somma voted aye.

All votes aye; motion carried 6-0.
