## SPECIFICATIONS AND GENERAL PROPOSAL REQUIREMENTS FOR THE REPAIRS AND RENOVATIONS AT THE JAMES ADKINS POOL IN THE CITY OF KYLE

## NOTICE TO RESPONDERS:

The City of Kyle is accepting proposals for the selection of a company's/contractors with expertise in design-build services for pool improvements at the James Adkins Pool. The location is the James Adkins Pool, located in the City of Kyle as stated in this RFP and posted on our website: www.cityofkyle.com. The City of Kyle invites qualified companies to submit proposals which comply with all applicable local, state, and federal regulations governing construction of said Aquatic Facilities including all associated agency or agencies permitting such projects. The proposal must provide but is not limited to complete architectural and engineering design and construction cost estimates for the construction of the repairs and renovations the following location: James Adkins Pool. The city is seeking a company with governmental pool repairs and renovations experience as well as experience working with public municipal agencies. ## REQUEST FOR PROPOSAL DEADLINE: 5:00 PM, WEDNESDAY, JANUARY 4, 2023

All proposals received will be reviewed by City Staff. The staff's recommendation will go to the Kyle City Council for final approval.

Sealed proposals should be clearly marked, "**REPAIRS AND RENOVATIONS FOR THE JAMES ADKINS POOL: RFQ-2023-02-PARD**". Any proposal received later than the specified time, whether delivered in person, postal mail or emailed shall be disqualified. The City of Kyle will not be responsible for delivering mail from the post office. The City of Kyle will not be responsible for proposals delivered to any location other than the one specified above. The City of Kyle will not be responsible for emailed proposals that did not get into "in-box". Respondents are encouraged to hand deliver their proposals well ahead of opening time or follow up to confirm their proposals were received before the deadline.

The City of Kyle reserves the right to reject any or all proposals submitted. Resolution 795-Adopted March 20, 2012: The City of Kyle City Council herby gives local preferences if the contractor meets requirements under the Local Government Code Section 271.9051.

The City of Kyle is exempt from taxation under the Sales Tax and Use Tax Laws, and proposals shall not include such taxes.

## SCOPES:

- A site visit is required prior to any company submitting a proposal. The site visit must be accompanied by a City of Kyle representative. Site visits may be scheduled during normal business hours between December 14, 2022, and January 3, 2023. To schedule a visit, please contact City of Kyle Director of Parks and Recreation as listed above.
- 2. This Request for Quote is for one (1) year of services beginning by January 17, 2023.
- 3. The Request for Quote is to include cost estimates to include, but not limited to supplies, design and/or construction of the list below for the James Adkins Pool.
- 4. The contractor shall provide an image showing the before and after image of what the upgrade or repair within RFQ.
- 5. Structural engineering drawings shall be submitted (if applicable).
- 6. Pool repairs and renovations specifications must be provided for floor/foundation, wall systems, interior finishes, doors, roof, exterior finishes, ventilation, accessories and signage, plumbing, electrical, and external utility connections.
- 7. It is customary and common for City Departments to request proposals for participation in programs funded or sponsored by the City. City parks are fully funded by City tax dollars. Funding for this project is available in the approved capital improvements plan. The agreement to provide these services must be open to all interested in submitting a proposal. By submitting an RFQ, the organization agrees to the terms and proposals being submitted.
- 8. The Kyle Parks and Recreation Department reserves the right to accept or reject any proposal submitted for any and all reasons.
- 9. Design, construction, and all associated costs are limited to only the area of the James Adkins Pool and components allowed within budget.
- 10. The designed repairs and renovations must meet the safety, design, and construction standards for quality a aquatic facility designs. The City of Kyle expects Gold Standard Design.
- 11. The repairs and renovations for the James Adkins Pool are as see below but not limited to the following:
  - a) New shade structures creating a "U" shape around the James Adkins Pool
  - b) Electrical Repairs
    - Pool lightings (within the pool)
    - Outdoor Light Fixtures within the Aquatic Facility
  - c) Repairs to aquatic concrete surround the pool
  - d) Leveling out previous splashpad
  - e) Adding a Cooling Deck
  - f) Repair or renovation of (4- Handrails, 3-ladders)
  - g) 12-new picnic tables
  - h) Renovation to the outdoor showers within the aquatic facility
  - i) New aquatic feature
    - Example: Wibit
  - j) Renovation to the aquatic facility restrooms
    - Sinks
    - Faucets
    - Shower heads
    - Hand drying machines
    - Baby changing stations
    - Toilet Spindles
- 12. The aquatic facility must be repairs and renovation in full compliance with all applicable local, state, and federal regulations during the construction phase.
- 13. Winning proposals shall work with the City to obtain access agreements and applicable liability insurance

policies.

- 14. The Contractor shall provide Certificate of Liability equal to or exceeding \$1,000,000 for General Liability, which will cover performance of its services under this agreement. The contractor will carry complete, adequate workmen's compensation insurance covering all employees of the contractor. Current certificates of all insurance, showing the City as an additional insured, must be submitted to and maintained on file with the City.
- 15. The Contractor will comply with all applicable federal, state, county and city ordinances and regulations in performing all services to be rendered by the Contractor under this Agreement. The City will comply with all applicable federal, state, county, and city ordinances and regulations in maintaining the Skate Park.
- 16. The contractor shall provide cell phone contact information to ensure communication during the design and construction of the James Adkins Pool.
- 17. The contractor shall provide a written timeline of construction and design.
- 18. The proposal shall include a company narrative that includes, but not limited to:
  - a) The history of the company
  - b) The experience of the company's principals
  - c) A descriptive narrative of the proposed pool improvements
  - d) The number of commercial pools and municipalities the company has worked with in Texas in the past five years similar to the scope and size of this proposal and a list of these Texas cities of similar size and scope with contact information for reference purposes.
  - e) Photos, video or links to videos of commercial pools that the company has completed during the last 5 years in Texas of similar size and scope.
- 19. The City of Kyle reserves the right to increase, decrease and/or adjust the pool needs based on adopted budget.

## RFQ RESPONSE FORMAT:

The proposal shall be submitted that shows the final total costs to complete all scopes listed. It is required that you complete and return the RFQ Response Page and all supporting documents as listed in Scope to be considered.

## TERMINATION FOR DEFAULT:

The City of Kyle reserves the right to enforce the performance of successful proposal in any manner prescribed by law or deemed to be in the best interest of the City in the event of breach or default of agreement. The City reserves the right to terminate the agreement immediately in the event the successful proposal fails to: 1) meet delivery schedules; 2) otherwise performs in accordance with these specifications. Breach of contract of default authorizes the City to, among other things, award to another proposal, purchase elsewhere and charge the full increase in cost and handling to defaulting successful proposal.

#### TERMS OF PAYMENT:

Any conditions other than payment in full 30 days after services provided shall be included in proposal. This includes deposits and payments made prior to construction must be written in the proposal.

## LIABILITY INSURANCE:

The Contractor shall provide Certificate of Liability equal to or exceeding all State minimum required coverage and listing City of Kyle as additional insured. Proposal shall also provide evidence of worker's compensation insurance for all employees performing work on City Property.

#### **RECORDS AND INSPECTIONS:**

Contractor shall maintain full and accurate records with respect to all matters covered under this agreement for a period of three years after the expiration or termination of this agreement. City shall have the right to access and

examine such records, without charge, during normal business hours. City shall further have the right to audit such records, to make transcripts therefrom, and to inspect all program data, documents, proceedings, and activities.

### PERMITS AND APPROVALS:

Contractor shall obtain, at its sole cost and expense, all permits, and regulatory approvals needed in the performance of this agreement.

REFERENCES: Required with Scope 11.

#### RFQ SUBMITTAL SCORING:

All complete proposals received will be reviewed by City Staff. The Staff's recommendation will go to City of Kyle Parks and Recreation Board for recommendation and then the Kyle City Council for final approval.
