**Location**: Mary Kyle Hartson Park/Burleson Road (Map Attached)

Dates: June 8th, July 13th August 10th, September 14th KMD-Squeeze Box, October 12th, November 9th,

**Fee**: Vendor Booth fee for each 10x10 space is \$35.00.

**Deadline**: Deadline to apply and pay is 2:00 p.m. the Monday before Market Day.

(ALL payment are due within 5 business days of receiving the approval email) Failire to make payment WILL result is loss of approval.

**Booth Vendors**: (All Vendors not offering food/drink intended to be consumed on site) Texas Sales Tax Certificate required as applicable. These vendors may sell items permitted within the CBD-2 Zoning District. Cottage Food Vendors must conform to Texas Law HB 970. Limited to 80 monthly vendors. All Vendors must be 18 years of age or older.

### **Rules & Regulations:**

- Food vendors can stay at the park from 8am 9pm.
- Vendors are responsible for applying for food permits through the Hay Health Department and have it displayed on event day.
- You are limited to offer the items you list on your application.
- Decisions will be based on receipt date of this application and number of events paid for.
- If spaces are not available when application and payment are received, staff will contact applicant.
- Vendors are responsible for their own display equipment, tents/canopies, utilities and set up.
- All items must be within the booth space. Roaming sales are not permitted.
- Vendors showing, offering, displaying or bringing notice to live animals are not permitted. Pets on leashand service animals are acceptable.
- The City of Kyle is not responsible for enforcing private company's or corporation's rules on multiplevendors at same events.
- All vendors are required to bring their own weights to hold your tent/canopy down. Vendors within the Mary Kyle Hartson Park will be PROHIBITED to utilize stakes/or nails to hold down canopies.
- Electricity is not provided by the city. Personal quiet generators with a less than 70 decibel rating may be permitted within your booth. Power cords, hoses or any items must stay within your booth space.
- Vendor spaces are first come first serve unless otherwise stated. The areas available will be designated by cones or area markers.
- Set-up CAN NOT begin earlier than 6:00am on the day of the event.
- All booths must be ready at least 15minutes before the market is set to start. Arrival 15minute before the market may result in cancellation of vendor application (NO REFUND)
- A \$20 fee will be charged to vendors that leave before the completion of the event.
- REFUND POLICY: No refunds, vendor may transfer credit towards other Kyle Parks and Recreation Event.
