- I understand and agree that all text, images and messages on the sign/banner will be in good taste and not offensive as determined by the Kyle Parks Board and/or Director of Kyle PARD.
- I understand and agree that there are no exclusive agreements and that competitive-type business signs/banners might be placed near mine.
- I understand and agree that my sign/banner will be appropriate size for posting.
- I understand and agree that the term of this agreement is one (1) year.
- I understand and agree that my agreement term begins the last day of the month that this agreement is accepted and paid for.
- I understand and agree that once my agreement has expired and the sign/banner has been removed, that I have thirty (30) days to pick up sign/banner.
- I understand and agree that returned checks for payment of this agreement will void this agreement.
- I understand and agree that the current rates are for this current fiscal year and subject to change in subsequent fiscal years. Current rates are:

Gregg-Clarke Park:

- Fields # 1 – 4 (Sportsplex) – Annual rate of \$5 per square foot with minimum of \$100
- Field # 5 (Next to Post Office) – Annual rate of \$10 per square foot with minimum of \$200
- Scoreboard at Field # 5 – Annual rate of \$480 (sign must be 4' tall and 8' wide)
