The City of Kyle, Texas was previously identified as a potential new entitlement community eligible for the Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) for FY23 but deferred its entitlement status. The City of Kyle is still potentially eligible for its entitlement status and CDBG funding in the estimated amount of \$212,780 for FY2024. Please note that this amount is an **estimate** and based on what your jurisdiction's funding allocation would have been if it had been an entitlement program participant in FY 2023. HUD makes no guarantee that these estimates are an accurate prediction of actual FY 2024 allocation amounts for any jurisdiction that decides to accept entitlement community status.

The City has until **September 15, 2023**, to provide our Field Office with its decisions via written correspondence if the City would like to accept or defer its entitlement status for FY2024. All communication should be sent electronically via email to the attention of Leti Ibarra, Director, at email: <u>CPD\_GeneralCorr-SAT@hud.gov</u> along with a courtesy copy to Valerie Reed-Sweed CPD Program Manager, at email: <u>valerie.m.reed-sweed@hud.gov</u>.

HUD will interpret a failure by a potential new grantee to respond in writing by **September 15**, **2023**, to mean that the jurisdiction has chosen to defer its entitlement status for FY 2024.

#### GUIDANCE FOR POTENTIAL NEW ENTITLEMENT GRANTEES COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

Potential new CDBG entitlement grantees may be identified annually when the Census Bureau releases updated population data. In addition, the Office of Management and Budget periodically issues bulletins that update their designations of metropolitan areas, counties included in metropolitan areas, and principal cities of those metropolitan areas. This memorandum provides guidance to potential new entitlement communities on the process required to become entitlement communities.

Once they are notified that they may be eligible for CDBG funding, potential new entitlement grantees are required to provide a written response to their local HUD Field Offices stating that they accept or decline their entitlement status. This response may be sent via email with a PDF attachment, facsimile, or mailed to the Field Office.

#### Part 91 Requirements

Potential new entitlement grantees must select a program year start date between January 1 - October 1. New grantees are encouraged to select a program year start date from July 1 - October 1 because of the amount of time required to develop a citizen participation plan, Consolidated Plan/Action Plan, train and hire staff on CDBG program requirements, and perform other necessary administrative actions required for start-up. In addition, because the Congressional appropriation process is often not completed by the start of the federal fiscal year, grantees with a program year start date of April 1 or earlier often do not receive their CDBG grants until well after their program year start dates.

Grantees are required to prepare a citizen participation plan that gives their policies and procedures for citizen participation in accordance with 24 CFR 91.105(a)(1). According to 24 CFR 91.105(a)(2), the citizen participation plan must provide for and encourage citizens to participate in the development of the consolidated plan/action plan, substantial amendments to the consolidated plan, and the annual performance and evaluation report. Low and moderate persons should be encouraged to participate in this process, particularly those that reside in areas where CDBG assistance may be targeted. Grantees must also encourage the participation of minorities, non-English speaking persons, and persons with disabilities as well. Participation by nonprofits, community-based organizations, public housing agencies, businesses, developers, and faith-based organizations should also be encouraged.

A grantee is required to prepare a Consolidated Plan every three to five years and an annual Action Plan that details the activities it will carry out with CDBG funds. 24 CFR 91.5 defines a Consolidated Plan as the document submitted to HUD that serves as the comprehensive housing affordability strategy, community development plan, and submissions for funding under any of the Community Planning and Development formula programs (CDBG, HOME, ESG, and HOPWA) prepared in accordance with the process detailed in Subpart C of the Part 91 regulations. Information required for a complete Consolidated Plan includes:

- A housing and a homeless needs assessment, which includes the jurisdiction's estimated housing needs, number and types of families in need of housing assistance for extremely low income, low income, moderate income, and middle-income families, renters or owners, elderly persons, single persons, large families, persons with HIV/AIDS and their families, and persons with disabilities.
- A homeless needs assessment which describes the nature and extent of homelessness; an estimate of the number of persons who are not homeless but require supportive housing; and the number of housing units occupied by low- and moderate-income families that contain lead paint hazards.
- A housing market analysis.
- A strategic plan which addresses non-housing community development needs and barriers to affordable housing.
- An anti-poverty strategy.

Grantees must address all of the requirements listed in the regulations.

HUD cannot provide an estimate of how many hours it would take to prepare a Consolidated Plan because the number would vary with each entitlement grantee. It is recommended that potential new entitlement grantees contact other comparable entitlement grantees or the HUD Field Office to ascertain this information.

The regulations at 24 CFR 91.15(a)(1) state that jurisdictions should submit their Consolidated Plans to HUD at least 45 days before the start of its program year. 24 CFR 91.15(a)(2) states that HUD will not accept a Consolidated Plan submission earlier than November 15 or later than August 16 of the federal fiscal year for which the grant funds are appropriated. It is important for grantees to understand that failure to submit their Consolidated Plan and Annual Action Plan by August 16 will result in the loss of funding for that fiscal year. Grantees should consult 24 CFR 91.220-230 for guidance concerning preparation of an annual Action Plan. Grantees are required to submit their Consolidated Plan in the eCon Planning Suite: Consolidated Plan and IDIS. The eCon Planning Suite includes CPD Maps, a mapping tool to assist grantees in determining where to target CDBG assistance. Grantees are also permitted to hire consultants to assist them in developing a Consolidated Plan. Consultants must be procured in accordance with the procurement requirements at 2 CFR 200.318-200.326, accessible at https://www.ecfr.gov/cgi-bin/text-

Once a grantee submits its Consolidated Plan/Action Plan to the HUD Field Office, HUD has 45 days to review and approve it. A Consolidated Plan/Action Plan is considered approved by HUD 45 days after HUD receives it unless HUD notifies the grantee before that date that its plan is disapproved. The Field Office may disapprove all or part of a grantee's Consolidated Plan/Action Plan. Reasons include but are not limited to the plan being substantially incomplete, developed without citizen participation and/or consultation, or HUD determined that one or more of the certifications submitted with the plan are inaccurate. A grantee has 45 days from the date of notification of disapprove by HUD to resubmit its Consolidated Plan/Action Plan, and HUD has 30 days to approve or disapprove the resubmitted Consolidated Plan/Action Plan.

Once HUD approves a grantee's Consolidated Plan/Action Plan, the HUD Field Office issues a grant agreement. After the grant agreement is executed by HUD and the grantee, an account is established in the grantee's name with the U.S. Treasury. This is the grantee's Line of Credit. Grantees must draw down funds by activity as they are needed rather than draw down the entire grant at once. Grantees are not permitted to draw down funds in advance of need and are required to minimize the time between the transfer of funds from the Treasury to disbursement by them or their subrecipients for eligible activities.

#### Preparation of Consolidated Plans/Action Plans

New CDBG grantees are permitted to incur costs for the preparation of their citizen participation plans, Consolidated Plans/Action Plan and other administrative costs before the date of their grant agreements. Under the authority of 24 CFR 570.200(h), reimbursement for pre-award costs, before the effective date of the grant agreement, a grantee may incur costs and then after the effective date of the grant agreement pay for those costs using its CDBG funds. Citizens must be advised of the extent that pre-award costs will affect future grants, and the costs must be in compliance with Subpart C of the Part 570 regulations and the environmental review procedures stated in 24 CFR Part 58. Pre-award authority is only permitted for preparation of the first year's Consolidated Plan/Action Plan.

#### **CDBG Program Administration**

CDBG grantees are permitted to spend no more than 20 percent of their CDBG grants plus 20 percent of program income earned that program year for planning and administration expenses. Planning and administration expenses include but are not limited to preparation of the Consolidated Plan/Action Plan, staff salaries for employees administering the CDBG program, and lease of office space. New grantees will require significant start-up costs associated with the development of their citizen participation and consolidated/action plans and capacity building.

New CDBG grantees are advised to carefully consider the options for administering their proposed CDBG-assisted activities. The option(s) selected may depend on the size of the CDBG grant, grantees' capacity for CDBG program administration, and the activities that they plan to carry out. In accordance with 24 CFR 570.200(f), a grantee may carry out CDBG activities:

- through its employees (the hiring of staff to administer the CDBG program is an eligible administrative cost).
- procuring with a consulting firm or for-profit grant administrator (the contract must be governed by the requirements of 2 CFR 200.318-200.326).
- through loans or grants made to subrecipients (see 24 CFR 570.500(c) for the definition of subrecipient) or
- the use of one or more public agencies (such as the county, a public housing authority or a redevelopment authority).

Grantees may use one or more of these options for carrying out CDBG-assisted activities. However, please note that 24 CFR 570.501(b) states that the grantee is responsible for ensuring that CDBG funds are used in accordance with all program requirements. The use of designated public agencies, subrecipients, or contractors does not relieve grantees of this responsibility. This means that grantees must ensure that designated public agencies, subrecipients, and contractors are carrying out CDBG-assisted activities in compliance with all CDBG program requirements. The grantee is responsible for monitoring such entities to ensure performance and compliance. The grantee remains responsible for any compliance problems and is financially responsible for any disallowed costs.

CDBG grantees are required to provide CDBG assistance only to areas within their jurisdictions' boundaries unless the requirements in 24 CFR 570.309 are met. This provision states that a grantee must determine that an activity funded outside of its jurisdiction is necessary to further the purposes of the Housing and Community Development Act of 1974 and its community development objectives, and that the grantee's residents are reasonably benefiting from the activity. It is important that grantees document the basis for this determination before CDBG funds are expended, and grantees must maintain that documentation. Urban counties are reminded that local governments which chose to opt out of the county's program or chose not to sign a cooperation agreement to participate in the county's program are not part of the CDBG Urban County. Even though these local governments may lie within the county's corporate boundaries, they are outside the jurisdiction of the county for CDBG program purposes.

### **Reporting Requirements**

CDBG grantees are required to be proficient in the use of the Integrated Disbursement and Information System (IDIS). IDIS is the system through which grantees enter activity accomplishments and draw funds from the Line of Credit. Grantees are required to report on all CDBG-assisted activities in IDIS on a regular basis. Grantees are required to enter information on the proposed activity and national objective. As the activity progresses, grantees are required to report on activity accomplishments and performance measures. For activities that will meet the low- and moderate-income jobs national objective, grantees are required to enter information on race and income of the beneficiaries and identify the number of jobs created or retained. For activities that will meet the low- and moderate-income limited clientele national objective, grantees are required to enter information on race and income of the beneficiaries. For activities that will meet the low- and moderate-income area benefit national objective, grantees are required to enter information on race and income of the beneficiaries. For activities that will meet the low- and moderate-income area benefit national objective, grantees are required to enter information on the Census block groups that comprise the service area of the activity. To obtain an IDIS account, a grantee's chief executive officer (or their designee) must fill out the IDIS Online Access Request Form, have it notarized, and submit it to their local HUD Field Office. For security and separation of duties purposes, multiple staff members will require IDIS access. 

To All Parties involved in the City of Kyle Community Development Block Grants

Thank you for this opportunity for input. As Communication and Grants Director, I write on behalf of 1,236 members of KASZ, the Kyle Area Senior Zone. Our nonprofit formed in 2006 to stop the destruction of the 1912 old opera house and city hall building that now serves as Kyle's only community center. In 2019 the city offered a piece of land, so KASZ hired a consultant, an architect, collaborated with City and Hays County officials, completed a capital campaign for \$600,000 and delivered plans for a 35,000 square foot community center.

The former city management had planned for block grant funding to support the staff and maintenance of this proposed community center. Currently there are no plans to go forward with this piece of land for a community center. Many citizens hoped that the covid recovery funding, ARPA, might be used to build a center but instead all that funding went to the sewer system. Now again we see the sewer in the top priorities for block grant funding and a combined library/recreation center/senior center is in last place at number 10.

Last month the City Council held a special meeting to discuss the community center issue as they rush to put something together by August for a bond issue. It was an open meeting and about 30 senior citizens attended but did not feel welcomed. Our board president received several texts

and phone calls reprimanding her for encouraging attendance. Senior citizens are a significant block of the population, we staff the city hall front desk, volunteer throughout the community and vote regularly. The stability and future of the City of Kyle depend on the relationship between the local government and its citizens. We must improve this relationship. Thank you for your consideration.







#### Q14 Reducing lot(s) zoning restrictions to assist with ease of building







# Q19 Senior Center, Library, and Recreation Center(s)



#### Q20 Construct sidewalks, natural trails, and multi-modal trails (the Vybe)



# Q24 Increase access to public transportation or the Uber \$3.14 Program




# Q25 Increase access to grocery stores







#### CITY OF KYLE CITIZEN PARTICIPATION PLAN

The City of Kyle is identified as an Entitlement City by the U.S. Department of Housing and Urban Development, and consequently, receives funding annually through the Community Development Block Grant (CDBG), and the HOME Investment Partnership Program. The amount of each CDBG, and HOME entitlement is determined by statutory formula. Within the statutory constraints of each of the HUD programs, the City of Kyle is able to develop its own programs and funding priorities.

In application for funding through these programs, the City of Kyle is required to develop and submit to the U.S. Department of Housing and Urban Development, a Consolidated Plan which identifies the housing and non-housing funding priorities of the community and the specific activities to be carried out with CDBG, and HOME funds. In developing the Consolidated Plan, the City is charged with the responsibility of consulting with local citizens, community service organizations, and others as applicable in assessing needs and determining the best use of program funds.

The City of Kyle has developed this Citizen Participation Plan (CPP) to adhere to 24 CFR Part 91, pertaining to the Consolidated Submission for Community Planning and Development Programs and 91.105 Citizen Participation Plan; local governments. Also, in accordance with 24 CFR Part 91.105(a)(3), the <u>City will provide this CPP in a format that is accessible to persons</u> with disabilities, upon request. The City's policies and procedures to encourage and allow for citizen participation in the development and submission of a Consolidated Plan, as well as any substantial amendments to the Plan, and reports of performance are outlined below.

#### I. ENCOURAGEMENT OF CITIZEN PARTICIPATION

- A. The City of Kyle shall take appropriate action to encourage the participation of all its citizens in the development of the consolidated plan, any substantial amendments to the consolidated plan, and on the Consolidated Annual Performance and Evaluation Report (CAPER).
- B. Particular emphasis will be placed on encouraging the participation by low-and moderate-income persons, particularly those living in slum and blighted areas and in areas where CDBG funds are proposed to be used, and by residents of predominantly low- and moderate-income neighborhoods, as defined by the City. The City of Kyle will take whatever action is appropriate in the encouragement of the participation of all its citizens, including minorities and non-English speaking persons as well as persons with disabilities.
- C. The City shall encourage, in conjunction with consultation with the Kyle Housing Authority, the participation of residents of public and assisted housing developments, in the process of developing and implementing the consolidated plan, along with other low-income residents of targeted revitalization areas in which the developments are located. The City shall make an effort to provide information to the housing

agency about consolidated plan activities related to its developments and surrounding communities so that the housing agency can make this information available during at least one of the two public hearings per year on the Consolidated Plan.

D. The City shall provide citizens with a reasonable opportunity to comment on the citizen participation plan, and on substantial amendments to the citizen participation plan, and must make the citizen participation plan public. The citizen participation plan shall be in a format accessible to persons with disabilities, upon request.

#### II. DEVELOPMENT OF THE CONSOLIDATED PLAN

- A. Before adopting the Consolidated Plan, the City will make available to citizens, public agencies, and other interested parties information that includes the amount of assistance the City is expected to receive (including grant funds and program income) and the range of activities that may be undertaken, including the estimated amount that will benefit persons of low-and moderate income.
- B. City staff charged with the responsibility of preparing the Consolidated Plan will meet and request input from local citizens, service organizations, the Public Housing Authority, and other interested parties through:
  - 1. The City will develop a portion of their website to be dedicated to the Consolidated Plan to foster and encourage citizen participation throughout the plan's development.
  - 2. The City will use an on-line Consolidated Plan Survey to provide citizens and stakeholders the opportunity to share input and/or ask questions during the 30-day period prior to a Needs Assessment Community Workshop. The Consolidated Plan Survey will be posted on the City's website and will also be available in hard copy at a designated City office location. Citizens and stakeholders will be made aware of the Consolidated Plan Survey through the City's website, interviews, media releases, email blasts, flyers at libraries, and social media outlets. The designated webpage for the plan can then be updated as needed with draft documents and notices of coming workshops.
  - 3. A Needs Assessment Community Workshop will be scheduled in a timely fashion to allow for sufficient time for preparation of the plan.
  - 4. A notice including the date, time, and location of the Needs Assessment Community Workshop will be posted to the City website, Facebook and the local newspaper at least 72-hours prior to the workshop. Input and comments collected during the 30-day comment period and workshop will be attached to the Draft Consolidated Plan.
  - 5. A Strategic Plan Community Workshop will be scheduled in a timely fashion to allow for sufficient time for preparation of the plan.

- 6. A notice including the date, time, and location of the Strategic Plan Community Workshop will be posted to the City website, Facebook and the local newspaper at least 72-hours prior to the workshop. Input and comments collected during the 30-day comment period and workshop will be attached to the Draft Consolidated Plan.
- 7. At least one Community Workshop will be held at a location easily accessible to all, prior to the development of the plan in order to obtain the views of citizens on housing and community development needs, including priority non-housing community development needs.
- 8. Scheduled consultation meetings with service organizations, the Public Housing Authority, and others as necessary.
- C. At the time the proposed plan is made available for public comment, a summary of the proposed Consolidated Plan will be published in the Hays Free Press or other local newspaper which maintains the greatest circulation.
- D. Paper copies of the proposed Consolidated Plan will be made available at City Offices and local libraries, for public review for a 30-day period. Notice will be given through the Hays Free Press or other newspaper of greatest circulation; the City website, Public Access Channel, Radio and TV regarding the comment period.
- E. A reasonable number of copies of the proposed Consolidated Plan will be made available free of charge to citizens and groups who request it.
- F. A copy of the <u>completed Consolidated Plan</u> will be made available, in hard copy and electronically, for public comment for 30 days before a request is made for City Council authorization to approve the plan and submit it to HUD.
- G. Paper copies of the <u>completed Consolidated Plan</u> will be made available at City Offices and local libraries, for public review for a 30 day period. Notice will be given through the Hays Free Press or other newspaper of greatest circulation; the City website, Public Access Channel, Radio and TV regarding the comment period.
- H. A presentation on the completed Consolidated Plan to the Mayor and City Council, noting the proposed activities to be carried out with CDBG, and HOME funds will be held, and the public will have the chance to comment, before the formal request is made for City Council authorization to approve the Consolidated Plan and submit it to HUD.
- I. In preparing the final Consolidated Plan, City staff will consider any comments or views of citizens received in writing during public comment period(s) or orally at the presentation to the Mayor and City Council. A summary of these comments or views, and a summary of any comments or views and the reasons therefore, shall be

made part of the Final Consolidated Plan.

#### **III. DISPLACEMENT OF PERSONS**

The City of Kyle does not anticipate any displacement to occur as a result of any HUD funded activities. All programs will be carried out in such a manner as to safeguard that no displacement occurs. However, in the event that a project involving displacement is mandated in order to address a concern for the general public's health and welfare, the City will take the following steps:

- A. A public hearing will be held to allow interested citizens an opportunity to comment on the proposed project and voice any concerns regarding possible relocation. Notice of the public hearing/meeting will be made as per the procedure noted in a separate section of the Citizen Participation Plan.
- B. In the event that a project involving displacement is pursued, the Community Development or other City staff will contact each person/household/business in the project area and/or hold block meetings, depending on the project size; inform persons of the project and their rights under the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, and respond to any questions or concerns.
- C. Relocation assistance will be provided in adherence with the City's Project Relocation Plan and the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

#### IV. SUBSTANTIAL AMENDMENTS

- A. Changes to the Consolidated Plan that constitute a Substantial Amendment include:
  - 1. A change in the use of CDBG, and/or HOME funds providing for the addition/deletion of a project including the purpose, scope, location or beneficiary of an activity.
  - 2 An increase in the funding of a previously disclosed CDBG or HOME activity, if the additional allocation equals or exceeds \$500,000.
  - 4. A change in allocation priorities or a change in the method of distribution of funds.
- B. City staff will insure that citizens and interested groups have an opportunity to comment on any substantial amendments to the Consolidated Plan.
  - 1. Notice of the proposed substantial amendment and request for comment will be made through the Hays Free Press or other newspaper of greatest circulation.
  - 2. Citizens will be provided a 30-day comment period to express views regarding the

substantial amendment before the amendment is implemented. Copies of the substantial amendment will be made available at the Dept. of Planning, the Office of the City Secretary, and at the Kyle public library.

3. In preparing the substantial amendment, City staff will consider any comments or views of citizens received in writing or orally. Comments can be addressed to :

4. A summary of these comments or views, and a summary of any comments or views not accepted and the reasons therefore, shall be made part of the substantial amendment to the consolidated plan.

#### V. CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)

- A. Notice of each annual performance report and request for comment shall be made through the Hays Free Press or other newspaper of greatest circulation.
- B. Citizens will be provided a 15-day comment period to express views regarding the performance report before the report is submitted to the U.S. Department of Housing and Urban Development. Copies of the CAPER will be made available at the Department of Planning, at the Office of the City Secretary, and at the Kyle public library.
- C. In preparing the performance report, City staff shall consider any comments or views of citizens received in writing or orally. Comments can be addressed to:

#### VI. PUBLIC HEARINGS/MEETINGS

Citizens are required to be provided with reasonable and timely access to local meetings, information, and records relating to the Consolidated Plan and the City's proposed and actual use of Community Development Block Grant, and the HOME Investment Partnerships Program through the following actions:

- A. Schedule of Public Hearings/Meetings
  - 1. The City will hold at least 2 public hearings each fiscal year to obtain citizens' views and to respond to proposals and questions to be conducted at a minimum of two different stages of the program year. The hearings shall address:
    - a. Housing and community development needs. In order for the City to obtain views of citizens on housing and community development needs, including priority non-housing community development needs, the at least one of these hearings must be held before the proposed consolidated pan is published for comment.
    - b. Development of proposed activities, proposed strategies, and actions for affirmatively furthering fair housing.
    - c. Review of program performance.
  - 2. Citizens will be given 15 days prior notice of each hearing with sufficient information published about the subject of the hearing to permit informed comment.
  - 3. If a hearing is scheduled as part of a City Council meeting, a notice of the public hearing will also be included in the City Council agenda which will be posted by the City Secretary 72 hours prior to the meeting date.
  - 4. Public hearings will be held at times and location convenient to potential and actual beneficiaries, and with accommodation for persons with disabilities.
    - a. The City will insure that meeting locations are centrally located, accessible by both private and public transportation, and present no barriers to persons with disabilities.
    - b. Upon timely notice (at least 72 hours), City staff will make special arrangements for persons who are hearing impaired or have a special need.
    - c. The City shall ensure that non-English speaking residents be presented with an opportunity to participate and comment in public hearings by conducting,

upon request, the hearing in Spanish.

- 5. Additional public hearings can and will be held upon the request of City Council and/or concerned citizen requests to City Council.
- 6. The City shall ensure that public meetings be held in neighborhoods that are in CDBG target areas in order to obtain citizen's views and to respond to proposals and questions.
- 7. Advertisement of public meetings shall be made both in English and Spanish in order to afford non-English speakers an opportunity to be aware of public meetings. Advertisements will be in the local newspaper of greatest circulation at least 2 weeks prior to the date of the meeting in order to provide timely notice to neighborhood residents.
- 8. As appropriate, press releases will be issued through TV, to announce special scheduled meetings.
- 9. As appropriate, flyers noting a neighborhood meeting's purpose and scheduled time shall be distributed at locations frequented by affected residents (i.e. neighborhood schools, recreation centers, housing authority, etc.)
- 10. The Public Access Channel shall be utilized to broadcast information about Consolidated Plan meetings, etc., in both English and Spanish.
- B. The intended use of the Community Development Block Grant Program, the HOME Investment Partnership Program, and other applicable HUD program funds will be publicized by and through:
  - 1. Public Comment Period and Presentation. Prior to the request by staff that City Council approve the proposed Consolidated Plan, there will be a 30day comment period and a presentation to the Mayor and City Council, where the public will have the chance to comment, on the specific projects proposed to be carried out will be identified.
  - 2. Neighborhood meetings. Citizens will be encouraged to attend and learn of the proposed and ongoing activities of the City, including the projects/programs funded and proposed to be funded through CDBG, and HOME, at neighborhood meetings held prior to the start of the fiscal year.
  - 3. City Council Budget Hearings. Proposed CDBG, and HOME budgets are discussed at City Council Budget Hearings, which are held approximately 60 days prior to the start of the new fiscal year. They are open to the public.

#### VIII. AVAILIBILITY TO THE PUBLIC

- A. City Council meetings will be aired through the Public Access Channel for the purpose of allowing all residents of the community to be informed of City Council Action.
  - 1. The Consolidated Plan, as adopted, substantial amendments, and the annual performance report, shall be available to the public, including the availability of materials in a form accessible to persons with disabilities, upon request, at the offices of Depthe Department of Planning.
- 2. It is the City's policy that all information required to be made public by the Texas Open Records Act, be made available for public review in accordance with Chapter 552 of the Texas Government Code. The City of Kyle will provide citizens, public agencies, and other interested parties with reasonable and timely access to information and records relating to the City's Consolidated Plan, and the City's use of assistance under the programs covered by 24 CFR 91 during the preceding 5 years.

#### IX. TECHNICAL ASSISTANCE

Technical Assistance shall be provided to groups representing persons of low and moderate income that request assistance in developing proposals, be it for CDBG, HOME or other projects covered under the Consolidated Plan.

A. City staff shall meet with group representatives informally as well as formally, to discuss program needs and provide guidance as applicable.

B. City staff shall coordinate with other City Departments to ascertain information needed and/or requested by group representatives.

#### X. COMPLAINTS

- A. The City of Kyle maintains an Open Door Policy and encourages citizens to express their needs and issues of concern. All grievances shall be addressed in a courteous and timely manner.
- B. Oral complaints will be addressed by the staff person receiving the complaint. If the complaint is not addressed to the satisfaction of the complainant, then the concern will be referred to the staff person's supervisor. If the complainant is still not satisfied, then the concern will be addressed by the Department of Planning. The nature of the complaint will be documented for further reference in the city's Customer Service system or other complaint documentation system, as appropriate.
- C. Written complaints will be addressed through a formal written response. Staff will respond to such complaints in writing within 15 working days after having received the complaint.

#### XI. NEEDS OF NON-ENGLISH SPEAKING RESIDENTS

City staff will accommodate the needs of non-English speaking residents to insure their participation.

- A. Newspaper and website notices regarding all HUD funded activities administered by the City, substantial amendments, and performance reports will be published both in English and in Spanish.
- B. Depending on the needs of the residents in attendance, staff will insure that public hearings are conducted in English and/or Spanish, as appropriate.
- C. Public comments will be received both in English and in Spanish during City Council meetings where the Consolidated Plan, substantial amendments, and the performance report are discussed.

#### XI. OTHER

- A. The 30-day public comment period for the initial version of this plan was from 06/14/23 to 07/14/23 as stated in the notice published in the Hays Free Press on 06/14/23.
- B. The City of Kyle reserves the right to amend its Citizen Participation Plan as it relates to the Community Development Block Grant Program, as necessary, in order to meet the needs of citizens of the community and changes in program requirements.
- C. Following City Council's approval of the amended Citizen Participation Plan, the City of Kyle is responsible for adhering to the citizen participation policies and procedures, as noted, in regard to the development and submission of the Consolidated Plan, Substantial Amendments, and the CAPER.
- D. The Citizen Participation Plan, as amended, does not restrict the responsibility or authority of the jurisdiction for the development and execution of the Consolidated Plan.
